Some claims need references; and (3) Format: There are 5 tables and 3 figures. A total of 33 references are cited, including 29 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Medsci was provided. 3 Academic norms and rules: The authors provided the Written Informed Consent and Institutional Review Board, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Startup funding for Youth Faculty by Shenzhen University. The topic has not previously been published in the WJCC. The corresponding author has 1 published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s).
