The topic is within the scope of the WJG. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: This manuscript presents the well-structured literature review on the localized gastric amyloidosis (LGA), a rare disease characterized by abnormal extracellular deposition of amyloid protein in the stomach. The paper is very well written, and the results are supported by several</p>	[Y]

informative figures and drawings, and provides the important leads as to diagnosis and therapies for patients with LGA; and (3) Format: There is 1 table and 6 figures. A total of 87 references are cited, including 14 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
