A language editing certificate issued by Changsha Shiyu Translation Service was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Animal Care and Use Committee Approval Form, and the Institutional Review Board Approval Form. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China, the Fundamental Research Funds for the Central Universities.
