The authors should discuss this point and explain their rationale why they decided to perform POEM instead of other alternative approaches. Other critiques are that the authors summarize the medical history to the concise relevant history. The questions raised by the reviewers should be answered; and (3) Format: There are 3 figures. A total of 16 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Wiley was provided. 3 Academic norms and rules: The authors provided the CARE Checklist, and informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGE. The corresponding author has not published articles in the BPG. This manuscript is the resubmission of Manuscript No. 38499 (Rejected). 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation" section, and add "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME
