2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the predictors of clinical outcomes after non-operative management of symptomatic full-thickness rotator cuff tears. The topic is within the scope of the WJO. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The study aimed to identify potential factors that might be predictive of patient-reported outcomes after conservative</p>	[Y]

treatment of complete rotator cuff tears (RCT). The topic is interesting and the investigation performed by the authors deserves attention for its originality. However, there are several limits of this study that must be highlighted. Some missing data and highlight the limits of the study should be added. The questions raised by the reviewers should be answered; and (3) Format: There are 7 tables and 4 figures. A total of 36 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJO. 5 Issues raised: (1) The title, authors' information, corresponding author, abstract and keywords should be added in the first page; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to

	<p>the reference list and list all authors of the references. Please revise throughout; (5) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text; and (6) The reference’s number cited in the text should be cited in the square bracket. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p>Editorial Office Director:</p> <p>Manuscript_FirstCommentByEditorialOfficeDirector</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Orthopedics, and the manuscript is conditionally accepted.
