Disease; the authors highlight the importance of performing a diligent search for etiologies or NRCD when there are persistent symptoms despite following a GFD and reinforces the need for close follow up in the first year of the diagnosis of CeD; and (3) Format: There is 1 table and 2 figures. A total of 25 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript.
