There are 3 self-citations. 2 Language evaluation: Classification: Grade A and Grade B. The authors are native English speakers. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJO. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; and (2) PMID numbers are missing in the reference list. Please provide the PubMed numbers to the reference list and list all authors of the references.
