A language editing certificate issued by eWorldEditing was provided. 3 Academic norms and rules: The authors provided the Written Informed Consent, CARE Checklist-2016, The Signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The authors need to fill out the CARE Checklist-2016 with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. Without financial support. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
