(1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: Since there is no approved anti-viral treatment for such management, the authors' suggestion is an interesting way of coping with such a disease. 	<p>should be answered; and (3) Format: There are 3 tables. A total of 46 references are cited, including 30 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade C. A language editing certificate issued by SNAS was provided. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJH. 5 Issues raised: (1) The key word "HCV" is missing in the title. Please add it; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to this study. 6 Recommendation: Conditional acceptance.</p> <p>Editorial Office Director:</p> <p>Manuscript_FirstCommentByEditorialOfficeDirector</p> <p>Company Editor-in-Chief: I recommend the manuscript to be published in the World Journal of Virology.</p>
