analysis were appropriate. The synthesized data collection is logical and dependable. References are used suitable and updated. Tables and figures of the study were clear and completed. The study is significant helpful for clinicians to choose the right anticoagulant in preventing stroke. However, there are some issues need to be addressed. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 5 figures. A total of 27 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and PRISMA 2009 Checklist. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJC. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) I found the authors did not write the "article highlight" section. Please write the "article highlights"

	<p>section at the end of the main text; and (5) the author should number the references in Arabic numerals according to the citation order in the text.
