The topic is within the scope of the WJCC. (1) Classification: Two Grades C and Grade D; (2) Summary of the Peer-Review Report: The authors showed clear images and histological findings of the cases. Also, they described the clinical features of IPNB and review of the literature. This article is useful</p>	[Y]

for understanding of IPNB for general physician. Readers might get useful information from this article. The questions raised by the reviewers should be answered; and (3) Format: There are 5 figures. A total of 15 references are cited, including 13 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and two Grades B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to this study. 6 Recommendation: Conditional acceptance.
