manuscript is the records of errors of the devices which may help the healthcare provider to select the devices. However, this statistic could not represent the whole errors in the real world. Although the results of this manuscript showed the complications and adverse patient outcomes along with the failure of the devices, the authors needed to comment about each mode of failure of the devices related with the clinical outcome for the future awareness. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 1 figure. A total of 12 references are cited, including 13 references published in the last 3 years. There are 3 self-citations. The cited articles are relevant to this study. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate. This study was conducted from a publicly available database, therefore, the Institutional Review Board Approval Form and informed consent were not required. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the
