The topic is within the scope of the WJCC. (1)</p>	[Y]

Classification: Four Grades C; (2) Summary of the Peer-Review Report: This is an interesting and rare case. In this case report, authors show that even cetuximab-based therapy has the potential to succeed in long-term survival of advanced squamous-cell head and neck carcinoma. This phenomenon has good clinical significance for similar patients.. The questions raised by the reviewers should be answered; (3) Format: There are 2 figures; (4) References: A total of 19 references are cited, including no references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
