They reported a chronic fibrosis background induced by hepatic BRUCE KO in mice that recapitulates the fibrosis background in HCC patients, and a BRUCE-dependent suppression of β -catenin activity through the suppression of PKA activity. The subject of this manuscript is of value, but there are a few of defects need to be modified. The questions raised by the reviewer should be answered; and (3) Format: There are 6 figures. A total of 47 references are cited, including 13 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the The ARRIVE Guidelines, and the Institutional Animal Care and Use Committee Approval Form or Document.
