The topic is within the scope of the WJGE. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The paper is an interesting and well-conducted meta-analysis on the topic of regional anaesthesia for</p>	[Y]

cholecystectomy. The presentation of the meta-analysis and the conclusion respects the principles for this type of paper. The conclusion also corresponds to the analysis. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 4 figures. A total of 31 references are cited, including 7 references published in the last 3 years. There is 1 self-citation (Ref. 24). The topic of the self-citations is related to this study. 2 Language evaluation: Classification: Grade A. The authors are native English speakers. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJGE. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (11) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to
