The topic is within the scope of the WJG. (1) Classification: Grade C, Grade C and Grade C; (2) Summary of the Peer-Review Report: This paper is well written, and the topic is interesting. However, the authors should explain why bilateral lymph node dissection was not performed in their practice. The</p>	[Y]

authors are suggested to provide future perspective in terms of shortening the operative time. Postoperative complications should be described. The authors need to discuss whether the inferior vesical artery should be preserved or not. The questions raised by the reviewers should be answered; and (3) Format: There are 11 figures. A total of 25 references are cited, including 3 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade A. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the Institutional Review Board Approval Form, the written informed consent, and the Biostatistics Review Certificate. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The authors need to fill out the STROBE checklist with page numbers (in empty space follow each item). No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange
