questions raised by the reviewer should be answered; and (3) Format: There are 5 figures. A total of 16 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by HARRISCO was provided. 3 Academic norms and rules: The authors need to provide the CARE Checklist-2016 with page number, and the signed written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) The reference cited in the manuscript should be superscript. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
