properly described. However, some questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 6 figures. A total of 33 references are cited, including 24 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade B and Grade C. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, The ARRIVE Guidelines, and the Institutional Review Board Approval Form. The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 4 grants. The topic has not previously been published in the WJG. 5 Issues raised: (1) The language classification is Grade C.
