The topic is within the scope of the WJGS. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: In this paper, the authors reviewed the existing knowledge on the role of neuromediators governing the pathogenesis of IBD, focusing on the reciprocal relationship among the gut microbiota, neuromediators, and host immunity. and the contents of the paper are very interesting in terms of better understanding of the pathophysiology and the new therapeutic approaches for IBD. The reviewer suggests the authors to add a Table in which twelve neuromediators described in the text are briefly summarized. The questions raised by the reviewers should be answered; and (3) Format: There are 3 figures. A total of 96 references are cited, including 25 references published in the last 3 years. There is 1 self-citation. The cited article is relevant to this study. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJGS. The corresponding author has not published articles in the BPG. This manuscript is the resubmission of Manuscript No. 58755 (Withdraw). 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) Please obtain permission for the use of picture(s). If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published; and

correctly indicating the reference source and copyrights. For example, “Figure 1 Histopathological examination by hematoxylin-eosin staining (200 ×).
