The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: It is a case report with clinical significance. However, the figure of the paratesticular mass should be provided. The authors should mention the importance of immunohistochemistry, as well as the type of</p>	[Y]

primary pathology. The authors should describe the imaging findings in a better way with details; and (3) Format: There is 1 table and 4 figures. A total of 18 references are cited, including 2 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B. A language editing certificate issued by LAMEN Solutions was provided.

3 Academic norms and rules: The authors provided the CARE Checklist-2016, and the written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG.
