The topic is within the scope of the WJSC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The review is well written and is easy to follow and understand. However, some questions raised by the reviewer should be answered; and (3) Format: There are 2 tables and 2 figures. A total of 189 references</p>	[Y]

are cited, including 88 references published in the last 3 years. There are 5 self-citations, which are related to the manuscript. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by International Science Editing was provided. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 2 grants. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents.
