extremely interesting and well presented, however some major revisions are needed to improve article quality; and (3) Format: There are 3 figures. A total of 10 references are cited, including no references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and Written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The language classification is Grade C.
