manuscript deals with prediction of response to neoadjuvant chemotherapy for liver metastases from colon cancer. It is very interesting and well written. However, further studies will be needed to evaluate the significance of different SNPs and to optimize the identification of promising candidates for various treatment regimens. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 3 figures. (4) References: A total of 40 references are cited, including 10 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
