(1) Classification: Grade B and two Grades C; (2) Summary of the Peer-Review Report: The authors investigated whether APOE polymorphisms may influence HCV-induced liver damage. The authors found that the E4 allele has protective effect against progression of liver fibrosis and degree of inflammation in HCV-infected patients. The study is well performed and well explained. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 2 figures. A total of 40 references are cited, including 7 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade A and two Grades B. A language editing certificate issued by a native English speaker was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by National Council for Scientific and Technological Development, Coordination for the Improvement of Higher Education Personnel. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure
