A total of 17 references are cited, including 14 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, STROBE Statement, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) The reference's number should be put in the square bracket; (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (4) Authors should always cite references that are relevant to their study. Please check and remove any references that
