The topic has not previously been published in the WJH. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to this study. Authors should not cite their own unrelated published articles. Please check and remove any references not relevant to this study. The authors self-referencing number should be no more than 3. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
