basement of applying second antibiotic in bone cement, summarized the research results for dual ALBC in in vitro test and hemiarthroplasty, revision or infection patients. It could be helpful for orthopedic surgeons, especially for selecting commercial ready-to-use ALBCs. However, some grammar questions should be carefully discussed. The questions raised by the reviewers should be answered; and (3) Format: There are 3 figures. A total of 37 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJO. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) The references' number cited in the text should be superscript; and (5) The column should be minireviews. 6
