more substantiation. When doing a comparison, in order to capture the readers' attention, numbers or graphs are needed. The questions raised by the reviewer should be answered; and (3) Format: There is 1 table. A total of 18 references are cited, including 15 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJV. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The reference's number cited in the text should be put in the square bracket, then make them be superscript; and (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
