There are 7 self-citations (Ref. 5, 70, 71, 93, 101, 135, 192). The topics of the self-citations are related to this study. 2 Language evaluation: Classification: Grade A and Grade C. The author is from United States. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents.
