The topic is within the scope of the WJM. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors discuss the causes that lead to olfactory dysfunction in patients with ANCA associated vasculitis</p>	[Y]

through a comprehensive and well written review of the literature. The topic is interesting. The reviewer suggests to mention sino-nasal inflammation, necrosis and atrophic changes in the mucous membrane as well sensorineural involvement are the most important mechanisms underlying olfactory dysfunction; and (3) Format: There is 1 table. A total of 39 references are cited, including 9 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJM. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I have changed the manuscript type "Review" to "Minireviews"; (2) I found no "Author contribution" section. Please provide the author contributions; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces. 6 Re-Review: Not required. 7 Recommendation:
