(1) Classification: Grade B; (2) Summary of the Peer-Review Report: The article demonstrated that Cyanidin-3-glucoside may be potential agent to inhibit liver carcinogenesis in rat model via modulation of cell cycle. of experiments provided by the institute also provided sufficient evidence. The experimental design is reasonable, and the data can prove the connection between Cyanidin-3-glucoside and cell cycle in the inhibition of liver carcinogenesis in rat model; and (3) Format: There is 1 table and 6 figures. A total of 68 references are cited, including 19 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Springer Nature was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Animal Care and Use Committee Approval Form. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Recommendation: Conditional
