The topic is within the scope of the WJO. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This is a nice well-written retrospective article dealing with an important issue in relation with THR. The questions raised by the reviewers should be answered; and (3) Format: There</p>	[Y]

are 3 tables. A total of 24 references are cited, including 5 references published in the last 3 years. There are 2 self-citations (Ref. 13, 14). The topic of the self-citations is related to this study. 2 Language evaluation: Classification: Two Grades A. The authors are from the United States. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate. The Institutional Review Board Approval Form, and the written informed consent were waived. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJO. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (4) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to this study. 6 Recommendation: Conditional acceptance.
