2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> Summary of the Peer-Review Report: The authors summarize a collection of 67 cases from literature for inflammatory pseudotumor-like follicular dendritic cell sarcoma and submitted as evidence review. However, there are many questions which need to be resolved. So far the quality can't reach the publishing requirement of WJCC. For citations where the author's name is indicated in the text, a superscript number should be placed following the name ( <i>i.e.</i> , "Pang <i>et al</i> "). For citations where no author is indicated, a superscript number should be placed at the end of the sentence. Respective examples are: "Ma <sup>[1]</sup> reported .....", "Pan <i>et al</i> <sup>[2-5]</sup> indicated ....." ; "PCR has a high sensitivity <sup>[6,9]</sup> ."
