2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a basic study of the alleviation of acute pancreatitis-associated lung injury by inhibiting p38 MAPK pathway on pulmonary microvascular endothelial cells. The topic is within the scope of the WJG. (1) Classification: Grade A; (2) Summary of the Peer-Review Report:</p>	[Y]

The study is complex and well done confirming that dose dependent blockade of a p38 MAPK inhibitor with SB203580 moderates SAP-ALI and may play a future role in the Rx of PMVECs and ARDS in individuals with severe acute pancreatitis. The questions raised by the reviewers should be answered; and (3) Format: There are 7 figures. A total of 55 references are cited, including 14 references published in the last 3 years. There are no self-citations (Ref. 26). The topic of the self-citations is related to this study. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Medica Communicus Asia was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Animal Care and Use Committee Approval Form. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China, Science and Technology Planning Program of Sichuan. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures.
