2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a frontier of the survival-associated alternative splicing events interact with immune microenvironment in stomach adenocarcinoma. The topic is within the scope of the WJG. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: The authors conducted database search to determine survival-</p>	[Y]

associated alternative splicing (AS) events in stomach adenocarcinoma (STAD). AS events in STAD were detected from TCGA SpliceSeq database and constructed an AS-signature prognostic model. The obtained data were visualized clearly using some network analysis. The association between OS-related AS events and cancer immunity was also investigated. However, some questions raised by the reviewer should be answered; and (3) Format: There are 7 figures. A total of 44 references are cited, including 23 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 2 grants. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) PMID and DOI

numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (5) The reference should be cited in the text in Arabic numerals in order, then put them in the square bracket and make them be superscript; and (6) Please obtain permission for the use of picture(s). If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published; and correctly indicating the reference source and copyrights.
