(1) Classification: Grade C; (2) Summary of the Peer-Review Report: This is an important subject and the authors have done a reasonable job of reviewing what is available for assessing the competence of an aging surgeon. The manuscript is well written and logically organized. However, some questions raised by the reviewer should be answered; and (3)</p>	[Y]

Format: There are 3 tables. A total of 61 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJO. 5 Issues raised: (1) The authors' information should be added in the first page; (2) The "Author Contributions" section is missing. Please provide the author contributions; and (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
