However it might add more depth to the case. The questions raised by the reviewers should be answered; (3) Format: There is 1 table; (4)</p>	[Y]

References: A total of 4 references are cited; (5) Self-cited references: There is no self-cited references. 2 Language evaluation: Classification: Grade B. The manuscript is reviewed by a native English speaker. 3 Academic norms and rules: The authors provided the Written informed consent and CARE Checklist (2016). No academic misconduct was found in the Bing search. 4 Supplementary comments: No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (2) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" sections to the main text, according to the Guidelines and Requirements for Manuscript Revision; (3) The authors need to fill out the CARE Checklist (2016) with page numbers. 6 Recommendation: Conditional acceptance.
