2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a basic study of the partially hydrolyzed guar gum attenuates non-alcoholic fatty liver disease in mice through the gut-liver axis. The topic is within the scope of the WJG. (1) Classification: Grade C;</p>	[Y]

(2) Summary of the Peer-Review Report: Authors should clearly state in the introduction section that the mechanisms underlying NAFLD/NASH are far from being clarified and the gut-liver axis is only a part of the pathogenesis of this disease, because of the complex, multidirectional pathophysiology involved in NAFLD. The questions raised by the reviewers should be answered; (3) Format: There are 4 tables and 6 figures; (4) References: A total of 46 references are cited, including 6 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com.
