The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review</p>	[Y]

Report: This topic is interesting, and it can help to find a treatment modality for colorectal cancer. In some parts of the paper you mentioned that you followed up the patients every 3 months, despite in other parts of your work you mentioned that this article is a retrospective one. Is the follow up of patients included occult blood in stool, GI endoscopy or not? The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 2 figures. A total of 47 references are cited, including 15 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B. A language editing certificate issued by ShineWrite was provided.

3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. The authors need to provide informed consent. No academic misconduct was found in the Bing search.

4 Supplementary comments: This is an invited manuscript. The study was supported by Science and Technology Department of Hubei Province; and The National Natural Science Foundation of China. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG.

5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that
