by the reviewers should be answered; and (3) Format: There are 2 figures. A total of 24 references are cited, including 14 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the CARE Checklist-2016 with page number. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors' information should be added in the first page; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The reference's number cited in the text should be put in the square bracket, then make them be superscript. 6 Re-Review: Required. 7 Recommendation: Suggest to transferring WJCC.
