The topic is within the scope of the WJG. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The overall structure of the manuscript is complete. The text and figures are well structured and the methods employed are logical and well described. However, the title</p>	[Y]

should be slightly shorter. The abstract should be summarized. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 6 figures. A total of 59 references are cited, including 18 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and Written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and STROBE Statement with page number. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 2 grants. The topic has not previously been published in the WJG. 5 Issues raised: (1) The author's information should be put in the first page number; (2) The title is too long, and it should be no more than 12 words; (4) The "Author Contributions" section is missing. Please provide the author contributions; (3) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (4) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (5) PMID and DOI numbers are missing in the reference list. Please provide the

	<p>PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (6) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text; and (7) The reference’s number cited in the text should be superscript. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p>Editorial Office Director:</p> <p>Manuscript_FirstCommentByEditorialOfficeDirector</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
