The topic is within the scope of the WJG.</p>	[Y]

(1) Classification: Grade B, Grade C, Grade C and Grade C; (2) Summary of the Peer-Review Report: The paper compared two- and four-antibody panels of MSI testing in CRC. It has an important cohort from a single centre. The information presented is of great importance for centres where the cost of diagnostic procedures could have an impact in health care systems or in countries where different systems may coexist. However, the questions raised by the reviewers should be answered; and (3) Format: There are 4 tables. (4) References: A total of 23 references are cited, including 2 references published in the last 3 years; (5) Self-cited references: There are 4 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
