The topic is within the scope of the WJGS. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The paper is interesting, well-written and structured. It summarized current knowledge on the subject, provides both, practical recommendations and ideas for further</p>	[Y]

research. However, the manuscript need minor revision. The questions raised by the reviewer should be answered; and (3) Format: There is 1 table and 4 figures. A total of 37 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJGS. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) Please obtain permission for the use of picture(s). If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published; and correctly indicating the reference source and copyrights.
