The topic is within the scope of the WJGS. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The authors evaluated the suitability of robotic and transanal surgery in the peri-COVID-19. The idea of</p>	[Y]

manuscript seems innovative and relevant. However, it would be great if the authors would acknowledge the limitations/drawbacks of the robotics and transanal and minimally invasive surgeries. Also if they can add the knowledge/experience of the outcomes with respect to these techniques during ongoing COVID pandemic. Incorporating a brief discussion regarding categorization/case selection for the same we also be appreciated; and (3) Format: There is 1 table. A total of 44 references are cited, including 41 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade A. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGS. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The references' number cited in the text should be put in the square bracket, then make them be superscript; (3) The column should be the minireviews; and (4) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to this study. Authors should not cite their own unrelated published articles. Please check and remove any references not relevant to this study. The authors self-referencing number should be no more than 3. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
