The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This paper compared endoscopic gastritis based on Kyoto classification between diffuse</p>	[Y]

	<p>and intestinal gastric cancer. However, there are some problems to be resolved. The authors should estimate the sample size for the number of patients included in the study; and (3) Format: There are 4 tables and 1 figure. A total of 51 references are cited, including 26 references published in the last 3 years. There are 13 self-citations, which are related to this study. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to provide STROBE Statement with page number. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p>Editorial Office Director: Manuscript_FirstCommentByEditorialOfficeDirector</p> <p>Company Editor-in-Chief: I recommend the manuscript to be published in the World Journal of Gastrointestinal Endoscopy.</p>
