figures. However, the outcome of the patient is not mentioned in the article and needs to be added. The questions raised by the reviewers should be answered; and (3) Format: There are 5 figures. A total of 15 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade C. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 1 grant. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The language classification is Grade C.
