The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors have described a case of NEN of breast, an uncommon tumor with</p>	[Y]

treatment and follow-up of about 8.5 years. This appears to be the strength of this article and the authors have comprehensively demonstrated the course of the disease and the management during this timeline; (3) Format: There are 2 figures; (4) References: A total of 23 references are cited, including 6 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com.
