The questions raised by the reviewers should be answered; (3) Format: There are 5 figures; (4) References: A total of 16 references are cited, including 4 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Written informed consent and CARE Checklist (2016). No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Zhejiang Province Public Welfare Technology Application Research Project , Project of Taizhou University and Project of Taizhou Central Hospital. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s).
