2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the successful diagnosis and treatment of jejunal diverticular haemorrhage by full-thickness enterotomy. The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors report a case of jejunal duodenal diverticulum that was successfully managed by surgery and had one year follow up without any re-bleeding. Authors mentions use of upper endoscopy, colonoscopy and</p>	[Y]

mesenteric angiography that could not identify source of bleeding. However, the questions raised by the reviewer should be answered; and (3) Format: There are 6 figures. A total of 62 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Akdeniz University Research Foundation. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; and (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
