A language editing certificate issued by Spandidos Publications was provided. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 2 grants. The topic has not previously been published in the WJGS. 5 Issues raised: (1) The references cited in the text should be superscript; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) The column should be minireviews; (4) The authors should add some figures or tables in the manuscript; and (5) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s). 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
